Thank you for submitting your Planning Permit Application for Partition of tax lot 100 of map 28S-15W-36DD on July 9th, 2020. We apologize for the delay in reviewing your application and appreciate your patience as we work through our backlog of applications due to the Coronavirus. This letter will serve as notice that the application as currently submitted is <u>incomplete</u>. In order to assist in our scheduling of your project, please address the issues with your application as outlined below before resubmittal.

The City reviews land use applications for completeness according to State law (ORS 227.178). Per Bandon Municipal Code 17.120.040, the City shall notify the applicant if an application is incomplete. Once notified, the applicant has 180 days to submit the requested information.

Further, a land use application must address each of the criteria and standards applicable to the proposed use, including any adjustments to standards requested in the application. It is the applicant's responsibility to provide persuasive evidence that the application complies with the approval criteria and applicable standards. Supplying the information requested by the City will provide the necessary documentation for an informed decision. Refusal to submit all or some of the missing information could result in a denial of the application.

Information Requested:

The applicant has proposed to parition an existing 2.26 acre lot on Highway 101 that contains a Tire/Lube Shop and a Carwash. The partition will separate the two structures into separate tax lots, with parcel 1 containing the car wash at 76,967 square feet and parcel 2 containing the tire/lube shop at 24,733 square feet. In order to process the partition application as presented, the applicant shall establish separate water and sewer service for each lot and indicate where the utilities will be located. The applicant must also submit approval from DEQ for separation of the two structures, ensuring that any sediment or run-off from each structure is taken care of before entering the drainage system. This application was also sent to the County Surveyor and County Assessor for review and their comments have been attached to this letter. Please address these issues and resubmit the tentative partition plat.
