The Planning Department has reviewed your application for a Conditional Use Permit to operate a Vacation Rental Dwelling at 1388 Face Rock Drive, received on April 21st, 2022, and has determined that it is complete as of today's date. The City has 120 days to exhaust all local review: September 13<sup>th</sup>, 2022.

Please be aware that a determination of a complete application does not guarantee a recommendation of approval from staff for your proposal as submitted, but rather signifies that you have provided the materials required to process your application.

A twenty-day public notice will be prepared and mailed for your Public Hearing at the earliest practical date, considering other previously submitted applications and requirements for public notification. Your application will be issued a project page on the City's website and all materials and relevant dates will be uploaded there. Staff will prepare a staff report that will be available one week before the hearing and will contain the relevant criteria and findings. The Planning Commission is the reviewing body for Conditional Use Permits, with appeals to the City Council.
