The City of Bandon has received a Planning Application requesting approval to construct a new Port office called the "High Dock building," on property zoned Marine Commercial (C-3). This project is also subject to Off-Street Parking & Loading requirements, Shoreland Overlay, Signage, and Architectural Review overlay. This site is also located in the floodplain, however this will be reviewed along with zoning compliance at a later date. This request requires a Commercial Plan Review and a Certificate of Appropriateness, which are Type II decisions.

The ordinance criteria applicable to this application are available to review online in the Bandon Municipal Code at www.cityofbandon.org. Oregon law states that failure to raise an objection concerning this application, either in person or by letter, or failure to provide sufficient specificity to afford the decision maker an opportunity to respond to the issue, precludes your right of appeal to the Land Use Board of Appeals (LUBA) on that issue. Failure to specify which ordinance criterion the objection is based on also precludes your right of appeal to LUBA on that criterion. A copy of the application, all documents and evidence relied upon by the applicant, and applicable criteria are available for inspection at the City Planning Department, copies will be provided upon request, at reasonable cost. A copy of the staff report, if a staff report is prepared, will be available for inspection seven days prior to the hearing and will be provided at reasonable cost, if requested.
