Additional Comments

The northern part of the parcel is part of a compensatory mitigation site for the subdivision. This is under a deed restriction and cannot be touched or dumped in. The original plat shows 9 lots on the strip along Spinaker Dr. Lots 5 and 9 in that strip contain the mitigation site. I don't know where the original Lot 5 intersects your tax lot 614, since the properties were reconfigured. I therefore don't know the exact boundary of the mitigation site, but it appears to be at a lower elevation than the surrounding lots (because the mitigation sites were not filled in). In addition, the mitigation wetland has a 5-foot buffer on the north and south boundaries. I don't know if that buffer is contained within the sunken area or not. The city may also have a buffer requirement separate from the 5 feet. If the boundary of the deed restriction is surveyed and on file with the city, you can use that as the northern limit of your yard. If you cannot confirm the boundary, I suggest you contact Lauren Brown, DSL Resource Coordinator for Coos County, to help sort this out (503-302-3290)
