ADOPTING THE MUNICIPAL BUDGET AND ORGANIZATIONAL CHART, AND IMPOSING AND CATEGORIZING TAXES FOR

FISCAL YEAR 2024-25

BACKGROUND:

A public Hearing to discuss the Fiscal Year (FY) 2024-25 City of Bandon Budget is set for June 3, 2024. The budget is prepared for an annual period.

ANALYSIS OF THE ISSUES:

Following the Public Hearing, the Council shall consider Resolution 24-14, which adopts the FY 2024-25 Municipal Budget and organizational chart, and imposes and categorizes property taxes for the General Fund, Bonded Debt Service, and Local Option Street Tax.

Fiscal Year 2024-25's Municipal Budget totals thirty-nine million, two hundred sixty thousand, three hundred ninety-four dollars (\$39,260,394). The Budget Committee approved and recommended adoption of the FY 2024-25 Budget at their April 29, 2024, meeting.

FISCAL IMPACT:

The proposed FY 2024-25 Municipal Budget is \$39,260,394.

RESOLUTION NO. 24-14

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BANDON, OREGON, ADOPTING THE BUDGET AND ORGANIZATIONAL CHART, AND IMPOSING AND CATEGORIZING TAXES FOR FISCAL YEAR 2024-25

WHEREAS, the City Council, after a duly authorized Hearing, is hereby adopting the Budget and organizational chart for Fiscal Year (FY) 2024-25 as recommended by the Bandon Budget Committee on April 29, 2024, and approved by the City Council on June 3, 2024.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Bandon hereby adopts the Budget for FY 2024-25 in the sum of \$39,260,394, now on file at Bandon City Hall.

BE IT FURTHER RESOLVED, that the City Council hereby imposes the taxes provided for in the adopted budget at the rate of \$0.4580 per \$1,000 of assessed value for operations, and in the amount of \$568,395 for bonds, and a local option tax for capital projects at the rate of \$0.8455 per \$1,000; and that these taxes are hereby imposed and categorized for Tax Year 2024-25 upon the assessed value of all taxable property within the District.

BE IT FURTHER RESOLVED, that this resolution will be effective at the beginning of the Fiscal Year on July 1, 2024, and appropriated as follows:
