BACKGROUND:

A public Hearing to discuss the Fiscal Year (FY) 2024-25 Urban Renewal Budget is set for June 3, 2024. The budget is prepared for an annual period.

A RESOLUTION OF THE BANDON URBAN RENEWAL AGENCY ADOPTING A BUDGET FOR FISCAL YEAR 2024-25

WHEREAS, the Bandon Urban Renewal Agency Board of Directors, after a duly authorized Public Hearing, is hereby adopting the Budget for Fiscal Year (FY) 2024-25, as recommended by the Bandon Urban Renewal Agency Budget Committee on April 29, 2024, and as approved by the Board of Directors.

NOW, THEREFORE, BE IT RESOLVED that the Bandon Urban Renewal Agency Board of Directors hereby adopts the Budget for FY 2024-25 in the sum of \$1,366,872, now on file at Bandon City Hall; and

BE IT FURTHER RESOLVED that the Bandon Urban Renewal Agency Board of Directors hereby categorizes its FY 2024-25 increment taxes and any amounts in the special levy as subject to the general government limit of Section 11b, Article XI of the Oregon Constitution; and

BE IT FURTHER RESOLVED that the Bandon Urban Renewal Agency Board of Directors hereby resolves to certify to the County Assessor for the District No.1 and District No. 2 Plan Areas a request for the maximum amount of revenue that may be raised by dividing the taxes under section 1c, Article IX, of the Oregon Constitution, and \$0 as the amount to be raised through the imposition of a special levy; and

BE IT FURTHER RESOLVED that the amounts for the Fiscal Year beginning July 1, 2024, and for the purposes shown below, are hereby appropriated as follows:
